<u>OVERVIEW</u>

In April 2021, the Australian Energy Regulator (AER) approved the access arrangement that will apply to the provision of gas network services by Evoenergy (formerly ActewAGL Distribution) from 1 July 2021 to 30 June 2026. The access arrangement describes the reference services that Evoenergy offers.

In line with the requirements of the access arrangement, reference tariffs from 2022–23 onwards are subject to annual variation of the access arrangement (reference tariff variation mechanism). Annual variations are subject to approval by the AER.

The Australian Capital Territory (ACT) and Queanbeyan-Palerang gas distribution network access arrangement 1 July 2021 – 30 June 2026 is available at https://www.aer.gov.au

The reference tariffs in this tariff schedule are as per the AER approved 2023–24 tariffs. The tariffs are expressed in 2023–24 dollars and are exclusive of goods and services tax (GST).
